

# COMMITTEE OF ADJUSTMENT NOTICE OF PUBLIC HEARING

## **MINOR VARIANCE APPLICATION #A03-24**

Please take note that under Section 45(1) of the Planning Act, the Committee of Adjustment for the Township of Guelph/Eramosa will be holding a Public Hearing to consider the following application:

SUBJECT10 Memorial Street, Eden Mills, Township of Guelph/EramosaPROPERTY:CON 2 E PT LOT 32

- REQUEST: 1. Relief from Section 4.4.1.2 of Zoning By-law 40/2016 to permit the conversion of an existing two-storey accessory building into an additional residential unit (ARU) with a floor area of 288.9 m<sup>2</sup> equal to 93.15% of the main dwelling, whereas the maximum floor area is 45% of the main dwelling up to a maximum of 130 m<sup>2</sup>.
  - 2. Relief from Section 4.4.1.4 of Zoning By-law 40/2016 to permit an additional residential unit (ARU) with a height of 5.2 m, whereas the ARU shall not exceed the height of the main dwelling.
  - 3. Relief from Section 4.2.5 of Zoning By-law 40/2016 to permit an accessory building with a height of 5.2 m, whereas the maximum height is 4.7 m.
