Purpose:

The applicant is requesting relief from Section 5.1.8 of Zoning By-law 34-95 to permit

a deck of 1.524 metres above finished grade to project into any required yard, whereas as the By-law indicates no more than 1.0 metre above finished grade.

By-law

Requirements:

Section 5.1.8 states as follows: Decks, Steps, Balconies or Patios – Notwithstanding the yard and setback provisions of this By-law, to the contrary, decks, balconies, steps and patios, may project into any required yard. Where the floor of any balcony or deck is more than 1.0 metre above finished grade, the setback requirements for

the principle use shall apply. For the purposes of calculating the required yards or lot coverage in any zone, these structures shall not be considered part of the

building.

Request:

Relief of .524 metres is requested from Section 5.1.8 from Zoning By-law No. 34-95.
