### COMMITTEE VACANCIES

The Township of Guelph/Eramosa is also seeking one member of the public to participate on the Guelph/Eramosa **Committee of Adjustment**. The Committee meets in the evening as required, based on application submissions. The Committee of Adjustment is authorized by the Planning Act to consider applications for minor variances from the provisions of the Zoning By-law and extensions, enlargements or variations of existing legal non-conforming uses.

The term of the Committees will coincide with the term of Council ending on November 30, 2010. Remuneration for these positions is \$75.00 per meeting.
