

NOTICE OF PASSING OF MUNICIPAL-WIDE DEVELOPMENT CHARGES BY-LAW

TAKE NOTICE that the Council of the Township of Guelph/Eramosa passed a Municipal-Wide Development Charges By-law 38/2018 on the 22nd day of May, 2018 under section 2(1) of the *Development Charges Act, 1997, S.O., 1997 c.27, as amended*:

AND TAKE NOTICE that any person or organization may appeal to the Local Planning Appeal Tribunal (LPAT), formerly the Ontario Municipal Board (OMB), under Section 14 of the Act, in respect of the development charge by-law, by filing with the Clerk of the Township of Guelph/Eramosa on or before **the 3rd day of July, 2018** a notice of appeal setting out the objection to the by-law and the reasons supporting the objection.
