In order to participate:

- 1. You must provide a brief typed bio (one paragraph) with a description of your art piece. This can be submitted with your application and payment at the Brucedale Township office or emailed to <u>kcoultis@get.on.ca</u> by Monday, May 29.
- 2. A **\$20 entrance fee** is required to offset the cost of set-up and the opening night reception.
- 3. Artwork must be submitted by Monday, May 29. <u>All submissions must be suitably framed, wired and ready to install, if not, you risk the</u> <u>chance of your piece not being displayed.</u>

- Artwork may be picked up after the Homegrown exhibit from the Rockwood Library any time after Wednesday, June 28, between 10am – 8pm. Submissions must be picked up no later than Tuesday, July 4. The Rockwood Branch of the Wellington County Library will not be responsible for artwork left after Tuesday, July 4, 2017.
- 6. Artists should plan to attend the Homegrown Opening Reception at the Rockwood Library and the Older Adult Centre on Thursday, June 1 from 5:30 7:30 p.m.
- 7. If you are selling your artwork, you will be responsible for all aspects of the transaction, including contacting purchaser, financial agreements and the transfer of art **AFTER** completion of the Homegrown show. There will be no exceptions.
- Your artwork should be insured, as the Rockwood Branch of the Wellington County Library or Guelph/Eramosa Township will not be held liable for any damage. (See below)
- 9. Please pick up invitations to the Opening Reception from the library or the Older Adult Centre during the month of May to hand out to friends, relatives and acquaintances.
