

NOTICE OF APPLICATION AND HEARING

This notice is to confirm that an application to appeal the **Non-Compliance Notice 2023-001(F)** issued to Michael Sheehy *(tenant)*, Patricia Marie Monk and Catherine Sheehy *(the owners)* at 8248 Indian Trail, legal address Eramosa CON 3 PT LOT 2 RP 61R715 PART 1 under the Township's Fence By-law 52/2007, has been received by Michael Sheehy *(the applicant)*.

The Fence By-law variance application is against the Non-Compliance Notice issued on January 31, 2023, which states:

DEFECT

1. Construction of an 8ft fence with the use of materials (scrap metal) not authorized by By-law 052/2007, causing an unsightly condition on the property.

As per Section 7.0 of the Township's Fence By-law 52/2007, the Owner of a property may apply in writing in the prescribed form and fee to the Township of Guelph/Eramosa Property Standards Committee to request a variance from the requirements of this By-law.

The applicant has requested that the order and notice of compliance issued be **modified** and/or rescinded.
