Nomination forms and all other candidate forms are to be filed with the Township of Guelph/Eramosa Clerk at the Guelph/Eramosa Municipal Office, 8348 Wellington Road 124, Rockwood (at Brucedale) during regular office hours, Monday to Friday commencing Friday, May 1, 2026 until the closing of nominations at 2:00 p.m. on Friday, August 21, 2026 (Nomination Day). ***Appointments are strongly encouraged.***

The term of office for the offices listed above will be from November 2026 to November 2030.

Nomination papers for candidates are available in the Township Clerk's Office or on the Township's election website at [www.getvoting.ca](http://www.getvoting.ca). Candidates must submit the prescribed nomination and endorsement forms, proof of qualifying address and pay the appropriate nomination filing fee cash, debit, certified cheque or money order (made payable to the "Township of Guelph/Eramosa"). Nomination fees are as follows: \$200.00 for the office of Mayor and \$100.00 for all other offices.

No person who proposes to be a candidate may solicit or accept contributions for election purposes or incur campaign expenses until they have filed a nomination paper.

### **Third Party Advertisers**

A third party advertiser is an individual, corporation or trade union that pays for advertisements or other materials that support, promote or oppose a candidate or issue.

Any eligible individual, corporation or trade union that intends to spend money on advertising must register as a third party advertiser.

Individuals, corporations and trade unions who wish to conduct third party advertising must register with the municipality where they want to advertise.

The registration of third party advertisers will be accepted at the Guelph/Eramosa Municipal Office, 8348 Wellington Road 124, Rockwood (at Brucedale), during regular office hours, Monday to Friday commencing Friday, May 1, 2026, until Friday, October 23, 2026. The registration form will be available from the office of the Township Clerk or [www.getvoting.ca](http://www.getvoting.ca).
