The Committee of Adjustment for the Township of Guelph/Eramosa will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O., 1990, P.13, as amended.

Purpose:

The applicant is requesting the following:

- 1. To permit an interior side yard setback of 1.8m (5.9ft), whereas the minimum required interior side yard setback is 3.0 m (9.84 ft).
- To permit the exterior alteration of the main dwelling to establish an accessory second unit that does not comply with the yard and setback requirements of the Zone in which such buildings are situated.
- 3. To permit the alteration of a building where a lot has a lesser lot area and lot frontage of more than 20% less than the required lot area and lot frontage.

Request: Relief from Section 7.2.5, Section 4.4.1.2, and Section 4.1.3 of the Township's Zoning Bylaw 40/2016.
