

## NOTICE OF APPLICATION AND HEARING

This notice is to confirm that an application to appeal the order issued to Kyoon-Tae Kim *(the owner)* at 154 Main Street North, Rockwood, legal address Plan 150 BLK C PT LOT 32 under the Township's Property Standards By-Law 50/2018 as amended has been received by Kyoon-Tae Kim *(the applicant).* The appeal is against the order issued on June 22, 2021, which states:

## With regards to the Convenience Store, Main Level:

- In the ceiling: 3" drain line runs from fridges to the front right corner of the ceiling. Has backfall that needs to be repaired.
- The kitchen drain coming from Unit B above has no p-trap. The drainage pipe is unsupported and serious backfall issues are present throughout its length, teeywe on its side.
- No support on Unit A kitchen drain and backfall as well.
- Toilets/tubs are not vented. Unable to confirm if vanity is vented.
- Water damage is visible in the back of the store does and there is no plumbing above it.
- Water damage in-store by fridges does not have any plumbing above it, but there is an HVAC pipe above. No visible signs of leaking from the HVAC above.

As per Section 40.0 of the Township's Property Standards By-law, the Owner of a property may apply in writing in the prescribed form and fee to the Township of Guelph/Eramosa Property Standards Committee to request a variance from the requirements of this By-law.

The applicant has requested that the order issued be **amended** to extend the time for compliance.
