

NOTICE OF APPLICATION AND HEARING

This notice is to confirm that an application to appeal the order **2022-009** issued to David Locke *(the owner)* at 8139 Indian Trail, legal address CON 2 W, PT LOT 4 under the Township's Property Standards By-Law 50/2018 as amended has been received by David Locke *(the applicant).* The appeal is against the order issued on May 17, 2022, which states:

Rear Yard

1. Various waste and debris including but not limited to: scrap wood, scrap metal, scrap vehicle tires, empty tanks and containers, bricks, waste bins full with various waste and parts, tarps, various house hold waste, a ford pick up truck (PL: BD29800) with a flat bad full with various waste and parts, propane tanks, discarded tables and doors, 3 metal fuel containers, approximately 22 metal barrels, a bathing tub, a large pile of bricks, metal scaffolding, rolls of chain-link fencing, a pile of metal roofing and etc.

2. Wrecked, discarded, and derelict:

a. Chassis of an old trailer, no license plates, (Sportsman's Choice) labels on the side, (Mr. Christie) label on the back.

- b. 3 Unlicensed, unused and derelict large trailers, an unlicensed utility/boat trailer
- c. 3 unused and unlicensed snow mobiles

3. Accumulation of construction equipment and machinery, creating an unsightly and unsafe condition. This includes but its not limited to: tractors, fork lifts and used discarded parts of various construction machinery and vehicles.

As per Section 40.0 of the Township's Property Standards By-law, the Owner of a property may apply in writing in the prescribed form and fee to the Township of Guelph/Eramosa Property Standards Committee to request a variance from the requirements of this By-law.

The applicant has requested that the order issued be **amended** to extend the time for compliance.
