## Participation during the Public Meeting:

To pre-register as a delegate (to speak or make comments), please email <a href="clerks@get.on.ca">clerks@get.on.ca</a>. You are encouraged to pre-register as a delegate as soon as possible. To ask questions or make comments on this matter during the Public Meeting, click on the "raise your hand" option located at the center of your control bar at the bottom of the screen. Dial \*9 to "raise your hand" if connecting by phone. The Chair of the meeting will acknowledge each attendee raising their hand in turn. When you are acknowledged, the Host will unmute your microphone. You will be required to "accept" this action on

your device. At that point, as in regular public meetings, state your name and address prior to asking a question or making a comment. When you are finished speaking, the Host will mute your microphone. Note: If you are not using the latest update of Zoom, the host may not be able to "invite you to speak" due to security issues. If this occurs, you will need to call in by phone to make a public comment. To avoid this, always check for the latest Zoom update prior to each

meeting. These instructions will be repeated during the meeting.

**TAKE NOTICE** that pursuant to the requirements of the Planning Act, R.S.O., 1990 as amended the Township of Guelph/Eramosa has received a complete application (ZBA 04-19) to amend Zoning By-law 40/2016. The Council of the Corporation of the Township of Guelph/Eramosa will hold a public meeting to advise the public of the application and to obtain public input prior to making a decision.

**THE PUBLIC MEETING** will be held on **Monday, March 1, 2021 at 1:30 p.m.** to consider an amendment to the Zoning By-law of the Township of Guelph/Eramosa pursuant to Section 34 of the *Planning Act*, R.S.O., Chapter P.13, as amended.

The proposed amendment applies to the property known as 197 Main Street South and legally known as Concession 4, Part of Lot 5, in the former Township of Eramosa, now in the Township of Guelph/Eramosa. The subject property consisted of three parcels (193, 197 and 209 Main Street South) which have been consolidated into one property. The property is zoned as Village Commercial – Holding Symbol (C1(H)), Village Commercial – Flood Suffix (C1(f)), and Environmental Protection (EP) Zone, and the subject property is shown on the inset map.

**THE PURPOSE OF THE APPLICATION** is to facilitate the construction of a residential apartment building by amending the zoning on a portion of the subject property from Environmental Protection (EP) Zone to a site specific Village Commercial (C1) Zone; clarifying permitted uses within the Environmental Protection (EP) Zone; and by lifting a Holding (H) symbol.

**ANY PERSON** may attend the public meeting and/or make written or verbal representation in support of or in opposition to the proposed amendment. If you wish to be notified of the decision of the Corporation of the Township of Guelph/Eramosa on the proposed zoning by-law, you must make a written request to the Township Clerk at the address shown below.

If a person or public body would otherwise have an ability to appeal the decision of the Council of The Township of Guelph/Eramosa to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to The Township of Guelph/Eramosa before the by-law is passed, the person or public body is not entitled to appeal to the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Corporation of the Township of Guelph/Eramosa before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

The above information is being collected pursuant to the Planning Act, R.S.O. 1990, CHAPTER P.13, Section 34. Information, including opinions, presentations, reports, documentation, etc., provided for or at a Public Meeting is considered public records. This information may be posted on the Township of Guelph/Eramosa website and/or made available to the public upon request. Questions about this collection should be directed to the undersigned.
