The Committee of Adjustment for the Township of Guelph/Eramosa will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O., 1990, P.13, as amended.

Location of Property: 6838 Wellington Road 124 (Royal City Nursery), Township of Guelph/ Eramosa – GUELPH DIV B CON 5 PT LOT 2; RP 61R9754 PART 4

Purpose: The applicant is requesting the following:
 1. To permit a maximum area of 542m² to expand an existing greenhouse/On-farm diversified use, whereas Section 21.183 states that the On-farm diversified uses shall be restricted to 444m², which shall include all related structures and required parking spaces. Based on the application a difference of 98m² is proposed.
 2. To permit a total of 7 shipping containers (2 – 12m and 5 – 6m in length) for storage purposes, whereas Section 4.3.9 states that the maximum number of shipping containers on any property shall be limited to 2.

Request: Relief from Section 21.183 and 4.3.9 of the Township's Zoning By-law 40/2016.


