227 Balaclava ST, Rockwood, Township of Guelph/Eramosa PLAN 150 BLK A LOT 69 PT LOT;68 RP 61R1945 PART 1

**Purpose:** The applicant is requesting the following:

- 1. To permit an exterior side yard setback of 2.438m (8ft), whereas the minimum required exterior side yard setback is 4.5m (14.763ft)
- 2. To permit a floor area of 12.6%, whereas the maximum permitted ground floor area for all accessory buildings is 10% of the total lot area for a lot in a Residential Zone with a lot area less than or equal to 8,000m<sup>2</sup> (0.8ha).

**Request:** Relief from Section 8.2.1.6 and Section 4.2.4.1 of the Township's Zoning By-law 40/2016.
