Purpose: The applicant is requesting the following:

1. To permit a driveway setback of 0.25m from the interior side lot line, whereas the minimum required setback from the interior side lot line is 1m.
2. To permit a driveway width of 7.05m, whereas the maximum permitted width is 6m.

Request: Relief from Section 5.2 of the Township's Zoning By-law 34-95, "The Rockwood Ridge Subdivision By-law."
