Purpose: The applicant is requesting the following:

1. To permit an interior side yard setback of 1.47m (4.82ft), whereas the minimum required interior side yard setback is 3.0 m (9.84 ft).
2. To permit the alteration of a building where a lot has lesser lot area of more than 20% less than the required lot area.

Request: Relief from Section 8.2.1.5 and Section 4.1.3 of the Township's Zoning By-law 40/2016.
