

**MINOR VARIANCE APPLICATION #A06-23**

Please take note that under Section 45(1) of the Planning Act, the Committee of Adjustment for the Township of Guelph/Eramosa will be holding a Public Hearing to consider the following application:

**SUBJECT PROPERTY:** 20 Gazer Crescent, Promenade Park, Township of Guelph/Eramosa  
PLAN 451 LOT 42

- REQUEST:**
1. Relief from Section 4.4.2.2 (b) and 7.2.5 of Zoning By-law 40/2016 to permit an interior side yard setback of 1.5m whereas 3m is required.
  2. Relief from Section 4.9 to permit a 1.5m side yard setback for both decks whereas a 2.5m yard is required to be maintained.
  3. Relief from Section 5.1.10.3.2 (b) to permit a driveway width of 10.71m whereas the maximum driveway width is 7.5m.
  4. Relief from Section 5.1.10.2 to permit a parking area located 0.43m from a lot line, whereas 0.6m is required, to recognize an existing condition.
