Relief from Section 3 of Zoning By-law 40/2016, to permit a modification to the definition of "Automobile Body/Repair Shop" to include service, maintenance, and/or minor mechanical repairs for motor vehicles whereas the current definition allows for major repairs, parts or systems replacement, body work or painting for motor vehicles
