REQUEST(S) -

The applicant for Minor Variance application #A04-25 has requested:

 Relief from Section 4.4.1.2 of the Township's Zoning By-law 40/2016 to permit an additional residential unit (ARU) in an accessory building with a floor area equal to 81% of the floor area of the main dwelling up to a maximum area of 174m² whereas the maximum floor area of an ARU is not permitted to be more than an area equal to 45% of the floor area of the main dwelling up to a maximum area of 130m².
