The term of office for the offices listed above will be from December 2022 to November 2026.

Nomination papers for candidates are available in the Township Clerk's Office or on the Township's election website at <u>www.getvoting.ca</u>. Candidates must submit the prescribed nomination and endorsement forms, proof of qualifying address and pay the appropriate nomination filing fee cash, debit, certified cheque or money order (made payable to the "Township of Guelph/Eramosa"). Nomination fees are as follows: \$200.00 for the office of Mayor and \$100.00 for all other offices.

No person who proposes to be a candidate may solicit or accept contributions for election purposes or incur campaign expenses until he or she has filed a nomination paper.

Third Party Advertisers

A third party advertisement is an advertisement in any broadcast, print, electronic or other medium that has the purpose of promoting, supporting or opposing a candidate in the election.

Between May 2 and October 24, 2022, third party advertising is subject to restrictions.

Individuals, corporations and trade unions who wish to conduct third party advertising must register with the municipality where they want to advertise.

The registration of third party advertisers will be accepted at the Guelph/Eramosa Municipal Office during regular office hours, Monday to Friday commencing Monday, May 2, 2022, until Friday, October 21, 2021. The registration form will be available from the office of the Township Clerk or <u>www.getvoting.ca.</u>
