Please take note that under Section 45(6) of the Planning Act, R.S.O. 1990, c. P.13, the Committee of Adjustment for the Township of Guelph/Eramosa will be holding a public hearing to consider the following application. This notice is being provided pursuant to Ontario Regulation 200/96, Section 3.

SUBJECT PROPERTY — 5059 Township Road 1, Township of Guelph/Eramosa DIV B CON 4 PT LOT 2

REQUEST(S) -

The applicant for Minor Variance application #A05-24 has requested:

- 1. Relief from Section 4.2.4.1 of the Township's Zoning By-law to permit a total ground floor area for all accessory buildings equal to 15% of the total lot area, where the by-law limits such area to 10% of the lot size for Agricultural (A) zones with lots under 8,000m²; and,
- 2. Relief from Section 5.1.10.3.2.b of the Township's Zoning By-law to permit a driveway width of 16.82m, whereas the maximum permitted width for a residential use is 7.5m.
