KEY DUTIES & RESPONSIBILITIES:

- Responsible and accountable for conducting general maintenance and repair to all municipally owned facilities and/or co-ordinate through a trade person the repair of said facilities.
- b) Operate light vehicles, commercial mowers, tractors, small grass cutting, hedge trimming machinery, power tools, radio communications equipment and other specialized seasonal maintenance equipment.
- c) Assist with supervision of all Park Summer Staff.
- d) Responsible and accountable for providing general information to the public and assisting them with their concerns and complaints when possible.
- e) Assist with construction and landscape projects.
- f) Move supplies, picnic tables and equipment as directed

- g) Clean washrooms, showers and other public use areas.
- h) Collect and dispose of garbage and litter as directed.
- i) Assist with setup, takedown and the operation of special events and functions.
- j) Setting up seasonal operations as directed (i.e. clearing trails, cleaning equipment, trail and park signage, and setting up sports fields)
- Responsible and accountable for completing and documenting regular playground safety and risk management checks associated with various Township owned lands and facilities.
- Equipment repair and maintenance or co-ordinates through a trade person the repair of said equipment.
- m) Will perform his/her duties and ensure that assigned employees/volunteers work in accordance with the Township's Safety Policy and Procedures as well as the Occupational Health and Safety Act, including all applicable regulations.
- n) Perform other related duties as directed by the Parks & Recreation Foreman or designate

EDUCATIONAL REQUIREMENTS

- a) Ontario Secondary School Diploma or equivalency.
- b) Post-Secondary Education related to Parks and Recreation, facility management, forestry, turf management or cemetery operations

QUALIFICATIONS:

- a) Certified Pool Operator (CPO) designation an asset.
- Minimum Class G Ontario Driver's License in good standing required; Class D-Z License an asset
- Knowledge of facility operations including facility automation, electrical, plumbing, security, building maintenance and risk management gained through experience in property/building maintenance
- d) Experience operating a wide variety of landscape and park maintenance equipment is mandatory
- e) First Aid and CPR training is required
- f) Chainsaw fall arrest and confined space entry certification training would be an asset.
- g) Electrical, plumbing, painting, dry walling and carpentry experience an asset.

- i) Working knowledge of the Township properties and programs is an asset.
